The Project (Phase 1) of Liuzhou New Universe Rongkai Solid Waste Disposal Kicks off

(29 November 2019, Hong Kong) **New Universe Environmental Group Limited** (“NU ENVIRO” or the “Company”; stock code: 436.HK) is pleased to announce that the comprehensive solid waste disposal project (phase 1) of **Liuzhou New Universe Rongkai Solid Waste Disposal Co., Ltd.** (“Liuzhou New Universe Rongkai”), jointly established by the Company, officially went into operation on 28 November. The project (phase 1) can provide an annual incineration disposal scale of 40,000 tons, a physical-chemical treatment scale of 9,000 tons, a stabilization/solidification treatment and safe landfill treatment scale of 30,000 tons, and a safe landfill storage capacity of 300,000 cubic meters.

Jointly funded and established by the Company and Guangxi Rongkai Huayuan Electropainting Industrial Park Investment Company Limited, Liuzhou New Universe Rongkai is mainly engaged in the construction of new facilities in Liuzhou, Guangxi to provide integrated treatment and disposal services for hazardous industrial wastes, including the construction of a comprehensive hazardous waste disposal plant and a hazardous waste landfill. The project includes two phases, with a total investment of RMB330 million. Once it is in operation, Liuzhou New Universe Rongkai can dispose of a total of 79,000 tons of hazardous wastes every year with advanced international disposal technologies such as incineration, solidification, physicochemical treatment and safe landfill.
