NU ENVIRO Chairman Attended 2023 Jiangsu-Hong Kong Economic and Trade Cooperation Conference and the Forum Between Principal Officials of CPC Jiangsu Provincial Committee and Provincial Government and Representatives of Jiangsu Enterprises

On 13 October, the 2023 Jiangsu-Hong Kong Economic and Trade Cooperation Conference was grandly held in Hong Kong. Guests including Mr. Xin Changxing, the Secretary of the CPC Jiangsu Provincial Committee; Mr. Fang Wei, Vice Governor of Jiangsu Province; and Mr. Cheuk Wing-hing, Deputy Chief Secretary for Administration of HKSAR, attended the event. They were joined by the representatives from



industrial and commercial organizations such as NU ENVIRO, the regional headquarters of European and American multinational companies in Hong Kong and business associations. A total of 37 cooperative projects in relation to business cooperation, trade and investments, technology and culture were signed at the event.

In addition, principal officials of the CPC Jiangsu Provincial Committee and the provincial government visited the Hong Kong Jiangsu Enterprises Association Center on 14 October. They exchanged views with Hong Kong enterprises such as NU ENVIRO and held in-depth discussions with each other. Mr. Xin Changxing, the Secretary of the CPC Jiangsu Provincial Committee, hoped that the Jiangsu enterprises in Hong Kong should continue to contribute their efforts to promote the integrated development of Jiangsu and Hong Kong.

NU ENVIRO is engaged in the provision of industrial and medical wastes and industrial sewage treatment services in Jiangsu Province. It provides comprehensive hazardous and general industrial wastes, regulated medical wastes and industrial sewage disposal and treatment services in various cities such as Nanjing, Zhenjiang, Yancheng and Suqian.
